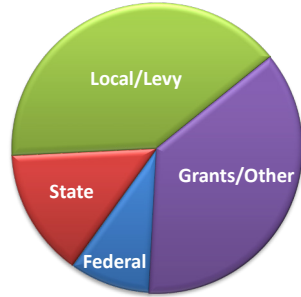

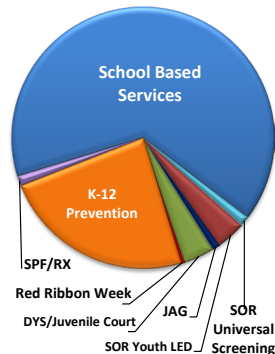

## A message from the Director



Heraclitus, a Greek philosopher, is quoted as saying “change is the only constant in life.” This past year (2021) is an absolute example of change. The second year of the pandemic brought an emergency rule to the Sunshine Law allowing public bodies to meet virtually to conduct business. However, that emergency rule expired on June 30, 2021. The Board of Directors and staff worked hard to accommodate the ever-changing landscape of virtual, blended and in person meetings as required to continue services throughout our five-county service district.

A bright spot in the pandemic was how our communities came together to support our one mill local levy. County Commissioners and Sheriffs in all five counties endorsed the levy. It is with their support the levy passed in all five counties. An amazing feat despite challenges brought on by social distancing and virtual meetings.

Behavioral health treatment services continued to be offered via tele-health but social distancing and CDC guidelines for quarantine and isolation proved difficult for residential treatment centers for the second consecutive year.

The Paint Valley ADAMH Board reached out to our community partners and treatment provider agencies to strengthen recovery supports and meet people where they are in their recovery journey. Funding from the State Opioid Response (SOR) Grant enabled programming in each county for “Jail In-Reach” assisting individuals with treatment options during and after incarceration. Another SOR funded program allowed each of the five county Community Action Boards to create “Wellness” programs for all individuals in recovery, providing a community of support and sober recreational activities.

The pandemic proved challenging in many ways and The Paint Valley ADAMH Board worked to meet the need of mental health services throughout each county. Hospitals, schools, and law enforcement realized the need for mental health workers within their facilities. This critical need places a strain on the workforce for mental health workers that has a lasting impact on the communities we serve. The Paint Valley ADAMH Board is committed to providing behavioral health services and working to retain and build a strong behavioral workforce in Southern Ohio.

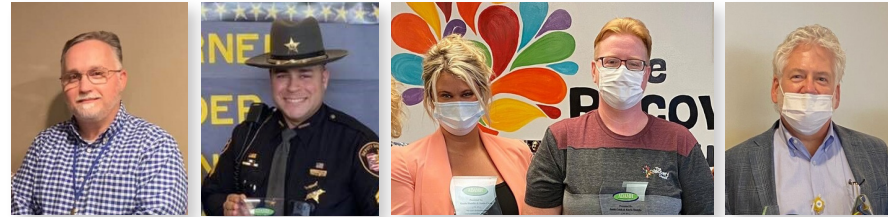

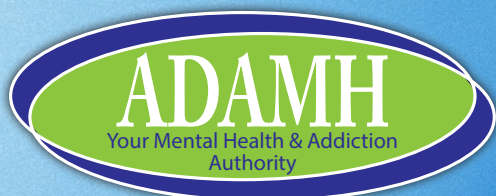

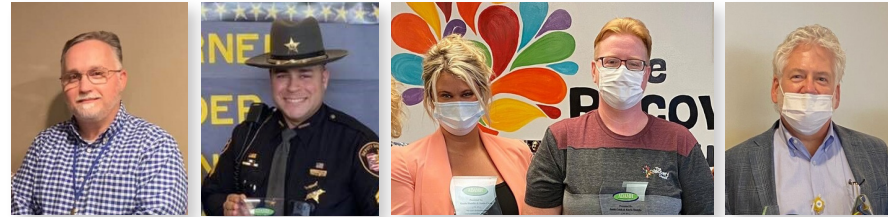
