New Business

Policies – New Board Agency Contract Policy, Update Holiday Policy to reflect Juneteenth and Information Technology Policies

Associate Director M. Swisher presented to the Board a new policy and updates to the Holiday Policy as well as the Information Technology Policies. If there are no required changes these policies will appear on the consent agenda for the next meeting for approval.

The Board has hosted a Recovery Celebration Banquet in September during Recovery Month. Due to COVID the banquet has been cancelled the last two years. The Board still wanted to recognize those individuals for their amazing work. The Board asked for nominations for the award categories and presented the winners with their awards. Associate Director Melanie Swisher presented the annual Client Rights and Grievance Report as well as the MUI annual review.

By-Law Changes

P. Dehner presented to the Board the preamble and then Article IV – Organization.... Section 4, which states the Planning and Reporting year for the board will be from July 1 to June 30. The Board changed the contracting timeline to calendar year therefore Dehner proposed to change the by-laws to match the calendar year instead of the state fiscal year. The Board is required to change the by-laws in accordance with Article 9 Amendments. This would require a two-week advance notice by mail as well as two thirds vote by the Board.

Dr. Jenks proposed to amend Article 9 to include email notification. Dehner stated she would verify our ability to change this and make the proposed changes prior to sending.

Investor Targets / PAX Plans

Manager of Prevention and Evaluations William Showman presented on the Investor Targets as well as PAX Plans for the schools in the Board area.

ADAMH Budget Revisions Calendar Year 2022

Director of Finance A. Dyer presented to the Board an update to the Calendar Year 2022 Budget.

F. Williamson MOVED to approve the proposed Calendar Year 2022 Budget as presented. Dr. B. Jenks SECONDED. Motion approved unanimously.

Accept CIT Expansion Grant Funding

Associate Director M. Swisher wrote a grant to work with local law enforcement to strengthen CIT efforts. The Board was awarded \$40,000.00.

H. Crosier MOVED to accept and appropriate the CIT Expansion grant in the amount of \$40,000.00

K. Kinney SECONDED. Motion approved unanimously.

Pike County Recovery Council, OHMAS Capital / Rescind and Adopt

Director Dehner explained to the Board in April 2021 a resolution was adopted to name Pike County Recovery Council's withdrawal management project on Maple Lane the Paint Valley ADAMH Board's #2 priority project for the 2021-22 biennium. A new facility has come on the market and Pike Recovery Council would like to change their project. The proposal is to move the residential women's facility for 31 women referred to as the Georgia Harris House to the property on Adams Road and then take the Georgia Harris House, located in Waverly, and proceed with renovations to accommodate withdrawal management beds. They would begin with 16 withdrawal management beds with a capacity of 31.

The Board will need to rescind the previous resolution passed in April and pass a new resolution, still declaring this as the Boards 2nd priority. This change in the planning and location does increase the project costs, but they have been in touch with OhioMHAS Capital, and they confirm the dollars are available.

H. Crosier presented the following Resolution for Adoption:

WHEREAS the members of the Paint Valley ADAMH Board are committed to assuring that residents of Fayette, Highland, Pickaway, Pike and Ross Counties have access to quality mental health and addiction prevention, treatment, and support services; and

WHEREAS local volunteer citizens of the Paint Valley ADAMH Board have identified our local needs and empowered community action through local partnerships with schools, courts, county commissioners, human service agencies, and other stakeholders on issues concerning mental health and addiction prevention, treatment, and recovery supports to provide the services necessary to meet Fayette, Highland, Pickaway, Pike and Ross County's needs; and

WHEREAS the Paint Valley ADAMH Board recognizes the need for additional substance use withdrawal management and detox services in Fayette, Highland, Pickaway, Pike and Ross Counties; and

THEREFORE, BE IT RESOLVED that the members of the Paint Valley ADAMH Board, on behalf of Fayette, Highland, Pickaway, Pike and Ross Counties, support the Recovery Council and their capital request for funds, for the renovations at the property address. The proposed

project is located at: Parcel 1: 2660 Adams Road, Beaver, OH

This property will move Georgia Harris House residents of the 31 Women's Residential to the proposed property on Adams Road, Beaver, Ohio. The Georgia Harris House will then become a 16 Bed Withdrawal Management / Detox Center with a capacity of 31 beds if needed.

BE IT FURTHER RESOLVED that the members of the Paint Valley ADAMH Board, on behalf of Fayette, Highland, Pickaway, Pike and Ross counties have designated this project as priority project #2 for the FY21-22 biennium.

BE IT FURTHER RESOLVED that the members of the Paint Valley ADAMH Board approves the project with an assurance of intent to support the applicant's program consistent with the applications and, in addition, to annually monitor the program and operations of the facility to assure compliance.
