Melanie Swisher presented documentation provided by contractors to explain change order. Due to the delay in starting due to Ross County Planning Commission not voting at the first planning commission meeting, and then not approving a variance, and the change in driveway per direction of Ross County Planning Office, rising costs of materials, prevailing wage, and tariff expectations, costs have risen. Contractor lost original carpenter, due to delay.
